The events we organise for the community have never before been so well attended. Around 200 Brookvale residents came to our September picnic.

This is now all about to be lost, and **we are facing a crisis**. The number of volunteers involved on the Committee has fallen to a drastically low level and the Association is in danger of being dissolved. This would mean that we will no longer have a 'voice' regarding changes to our living environment and we would lose the Hall to whoever the Council decides to grant the lease.

If you care about this historical area and the constant battle to maintain its identity together with encouraging a more cohesive community, please consider joining the Brookvale Community Association. The time you would have to give up will be minimal, there is one meeting a month and of course the social events to help organise, which are great fun for everyone. September crime meeting

The public meeting on Crime & Safety in Our Community was a great success. Thank you to all the residents who came along on 14th September to be part of the lively discussion.

Our local beat bobby, PC Lee Stanbrook, was joined by officers from Hampshire County Council's ACSO scheme (Accredited Community Safety Officers) who work alongside the police, dealing with lower level crime and nuisance behaviour, allowing the police to concentrate their resources on tackling more serious crime.

Officers from Basingstoke & Deane Borough Council were also present and discussed ways in which the council is trying to reduce crime and Anti-Social Behaviour. We also had two representatives from the local Neighbourhood Watch Association give a presentation on how Neighbourhood Watch can empower local residents to tackle the issues of crime in our community.

It was very clear from the views that residents expressed that there is definitely a perceived increase in crime, regardless of what the official statistics actually are. Specific issues raised included:

- anti-social behaviour caused by children as little as four years old, up to their late teens
- vandalism to public property and parked cars (especially at night time, caused by young drinkers on their way back home from town)
- vandalism and overt drug dealing at the Downsland Parade shops
- night time racing/speeding on Worting Road and Churchill Way
- securing shared alleyways between houses

PC Stanbrook again reiterated the importance of reporting crime and anti-social behaviour. He explained that police resources are naturally concentrated on areas where crime is being reported. If more crimes were reported, no matter how small or insignificant they might seem, we would have more resources dedicated to our area.

This is the biggest point of action on which you can have a direct impact. Even if you are calling after an event has happened, if it's just a case of kids

causing havoc on an ongoing basis, help the police to build up a picture of the problems we face in our area. Several car wing mirrors were kicked off of cars parked in Lower Brook Street a few days ago and yet only a handful of people bothered to report the incident.

if you don't feel it's worth your effort to pick up the phone and report it, please think again. We are aware that there might be some confusion over who to call to report incidents like these, so we have put together a cut-out-and-keep guide below to keep by or under your telephone. Please use it. Please put the Hampshire Police number into your mobile phone and use it when you're out and about in case you witness a crime or anti-social behaviour in progress.

Several residents put their names forward to establish local Neighbourhood Watch schemes. We look forward to further developments on that front.

Since the meeting, there has been a notable increase in ACSO patrols in the area and PC Stanbrook's beat has been split into two, allowing him to spend more time in a smaller area whilst a colleague takes on the other half of his beat (he still looks after Brookvale).

Successful picnic event

It's hard to believe now with the awful weather and darker evenings now upon us, but we were fortunate to have glorious summer weather on the day of the picnic. Judging by the smiling 200+ faces that joined us throughout the afternoon, it seemed everyone thoroughly enjoyed themselves.

We built upon the success of our 2004 picnic, introducing live music from a fantastic local school steel band, a bouncy castle for the kids (and also the adults at the end of the afternoon!) and competitive games and races.

Thank you to Eric, Marco Polo, BCOT, Rejuvenate and Esperanto's for their donated raffle prizes and also to Cllrs John Shaw and Doris Jones for all their help. Thanks also to the guys and girls from the Hampshire Fire Service who were on hand to give demonstrations and fire prevention advice.

193 May Street

The new owners of 193 May Street have finally put in a planning application, despite having been developing the property without consent for several months. The owners tried to pull the wool over the community's eyes and didn't display the statutory site notice correctly in an attempt to get through the public consultation period without any objections being raised!

A council officer actually had to come down to the site to put a site notice up and start the proper 21-day consultation period. We still aren't satisfied that the notice has been placed in a prominent enough location.

The owners are planning on converting the old DriveSound building into an Afro-Caribbean take-away/cafe/snack-bar that would be open from 9am to midnight, six days a week.

Already, signage which contravenes the Town & Country Planning (Control of Advertisements) Regulations has been attached to the building. It has been reported that the applicant wishes to hold street parties at which food will be cooked and served in the street and music will be played with no regard for local residents. There is very little detail about the proposed business in the planning application. Our greatest

concerns are: noise and disturbance to residents, cooking odours, the already strained parking situation getting worse, an increase in through traffic to our area, the degradation of a residential conservation area and the possible increase in loitering by youths who will use the snack bar as a drop-in centre.

Many residents have contacted us to raise significant concerns to the plans.

One wrote to us saying, "my young daughter's bedroom window is just 10 metres away! The increase of traffic, noise and disturbance will frighten her and disturb her sleep."

Another resident commented, "where will all the customers park? The street is struggling with residents' own parking as it is. And imagine the litter that will be chucked about in our street, and the noise in our Conservation area!"

It is expected that the application will be refused by the Planning Officer managing the case under delegated authority, and that it won't even make it to the decision committee. But this might not happen and the applicant can always appeal against the decision.

A number of residents have decided to go around canvassing for petition signatures. We also urge you to write in to voice your objections **before 17th November** (the cut-off date) - nothing makes more of an impact to the decision committee than a pile of written objections.

A total of 174 breaches have been discovered by council officers and all of them will be enforced!

The Conservation Order came into effect in 1999. If you or a previous owner has carried out work to a property in the Conservation Area without planning consent, you will be forced by legal proceedings to put things back the way they were. Works that are up for scrutiny include: satellite dishes on front elevations (they must not be visible from the street), replaced walls, windows and doors, works to the roof and chimneys and removal of any period features.

The Planning Department is recommending that residents who are aware of unpermitted work to their property are upfront and honest and seek retrospective approval for the work by submitting a planning application. Approval will be, of course, subject to normal planning regulation. Call (01256) 844844 for more details.
